How do I Qualify?

- Rebate offered to **non-residential** customers served by The Glencoe Light & Power Commission.
- The Glencoe Light & Power Commission reserves the right to inspect installations before issuing rebates and to perform a random verification audit of your project. If the application is found to not comply with rules and qualifications, any rebate amount may be adjusted. Projects with rebate payments over \$5,000 require on-site verification.
- Customer must apply for rebate within one year of purchasing equipment. The purchase date is the date shown on the customer's invoice.
- Invoices and specifications must accompany rebate application.
- Rebate paid cannot exceed 50% of the project cost. Maximum annual rebate dollars per customer will not exceed \$25,000.
- Rebate requests are processed on a "first-come first-served" basis.
- Rebate requests are processed on a "first-come first-served" basis. Annual rebate funds are limited and payouts could be paid over several years. Rebate program qualifications and amounts are subject to change at any time. The customer is responsible for checking with The Glencoe Light & Power Commission to determine whether the program is still in effect.
- Qualifying customers must apply for rebate by November 30, 2026.
