What Are The Benefits of Variable Frequency Drives?

- Use larger horsepower motors.
- Have a high degree of throttling (control valve, damper, and other system-control devices).

How Do I Qualify?

General Qualifications

- Rebate offered to non-residential electric customers served by The Glencoe Light & Power Commission.
- Rebate Application including Rebate Calculation Table must be completed. *Incomplete and/or illegible applications will not be processed.*
- To qualify for rebate, VFDs must meet the following eligibility requirements: have a True Power Factor of 0.90 or higher and be tied to an automated control system.
- Rebate applies only to new VFDs installed on fans and pumps up to 200 HP. (VFDs installed on equipment other than a fan or pump, or greater than 200 HP, may qualify under the Custom program.)
- Rebate based upon lower of the rated VFD-controlled horsepower or the motor horsepower.
- Customer must apply for rebate within one year of the purchase date shown on the equipment invoice.
- Qualifying customers must apply for rebate by *November 30, 2025.*
